



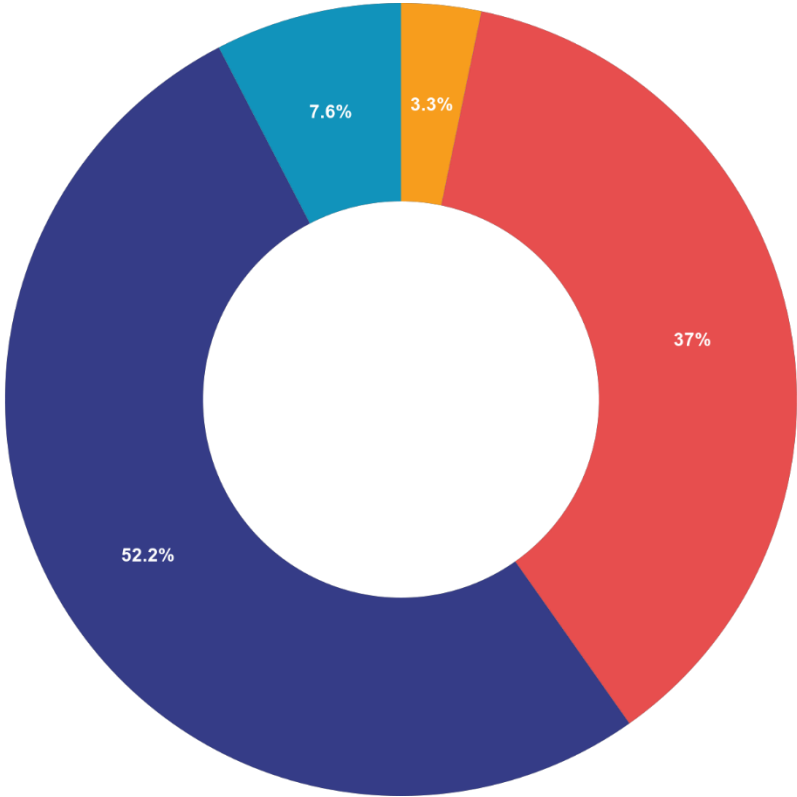
GFWC RI Women's Issues and Past Experiences with Gender Discrimination and Injustice

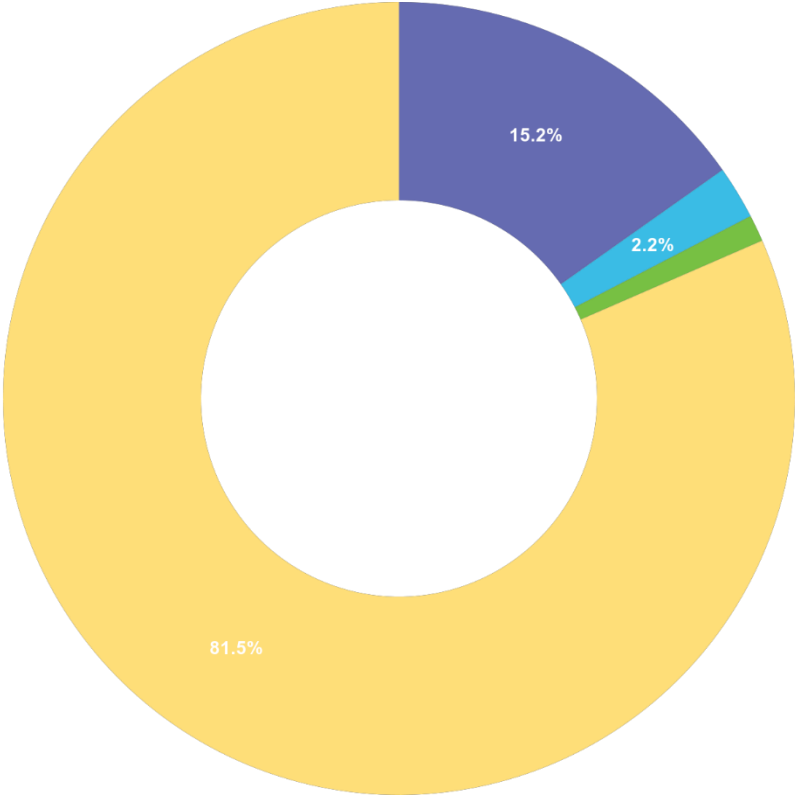

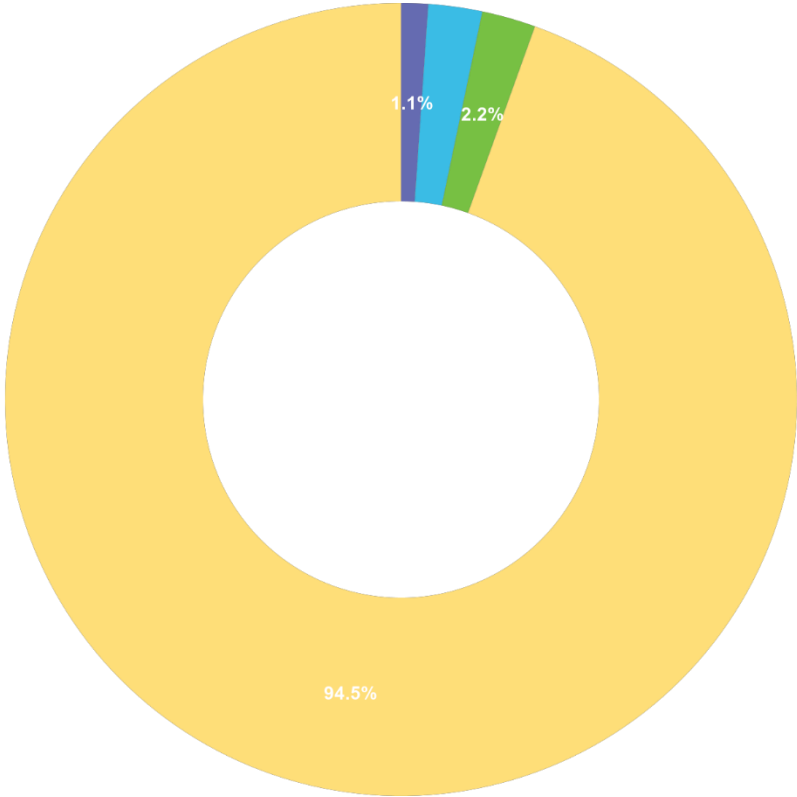
Q2 Have you ever been refused a loan or mortgage, based on your own (individual) credit history?

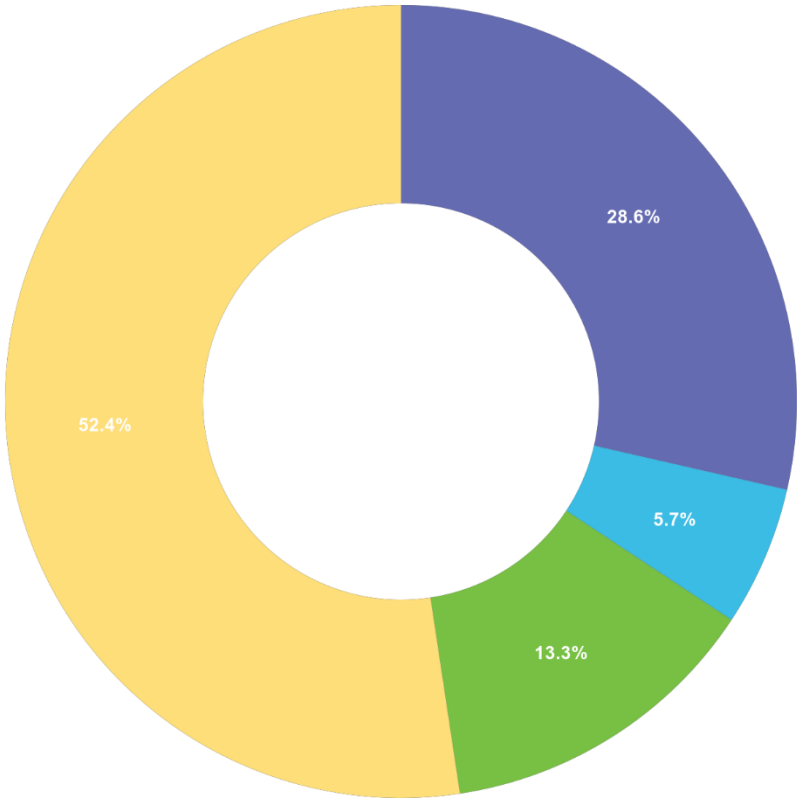
Q3 Have you ever been refused child support or alimony?

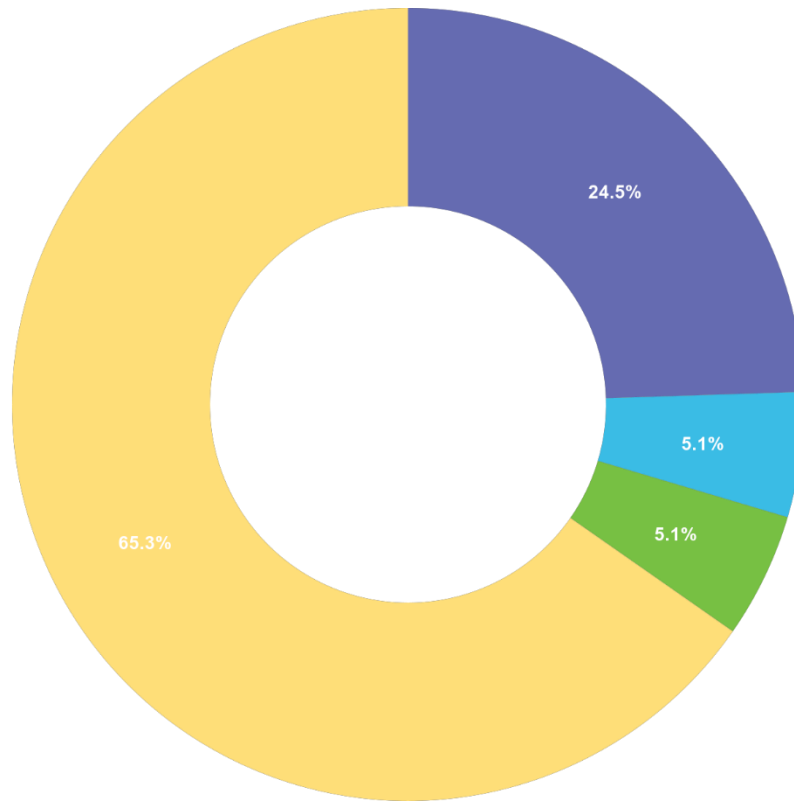
Q4 Have you ever known that you have been paid less than a man in a similar work role ?

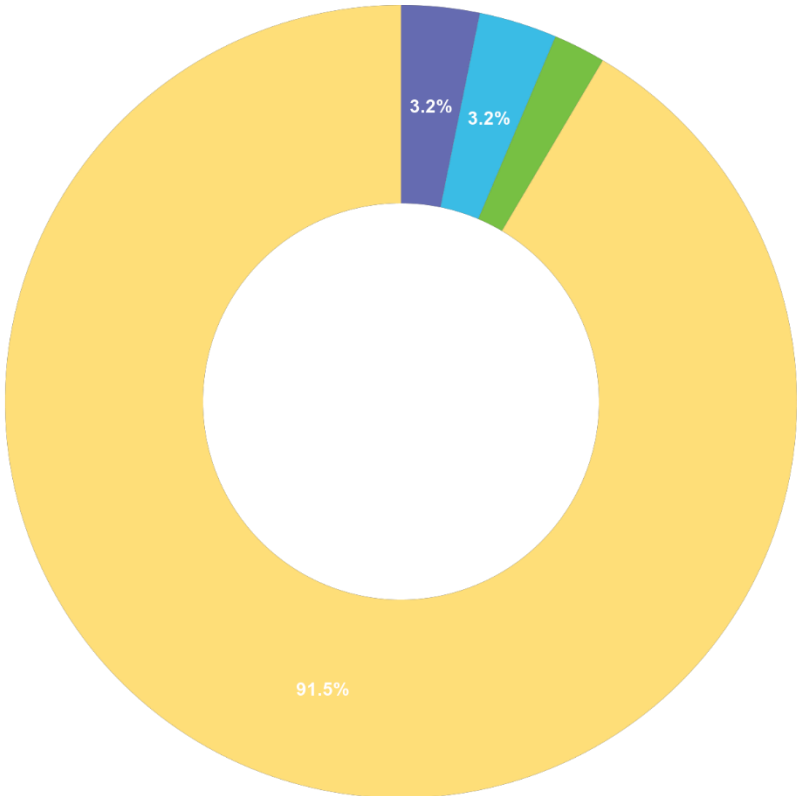
Q5 Have you ever been denied a credit card, when applying on your own (not a joint account)?

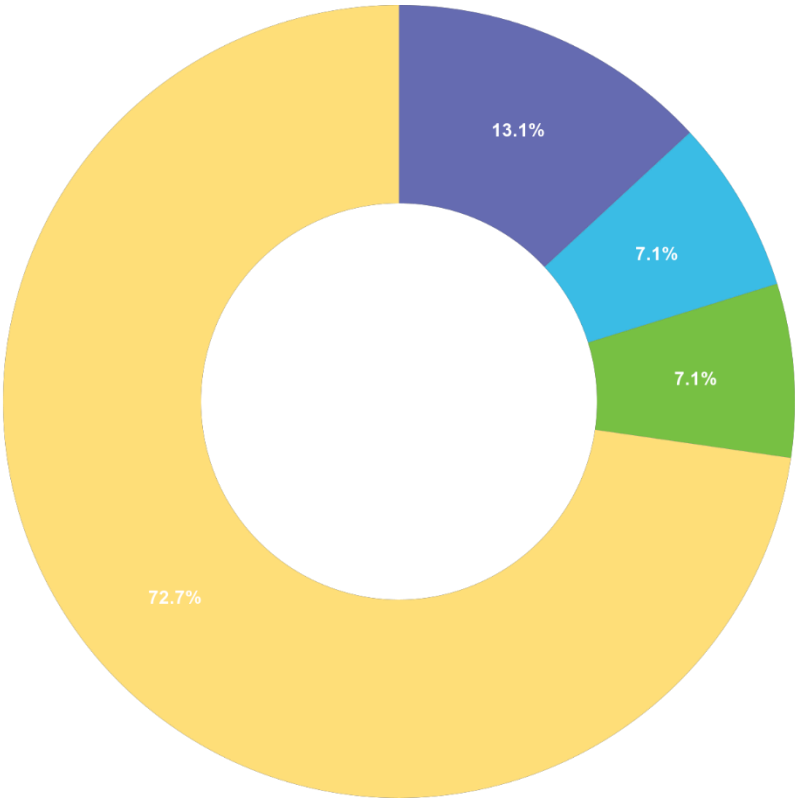
Q6 Have you ever been denied a checking account, when applying on your own?

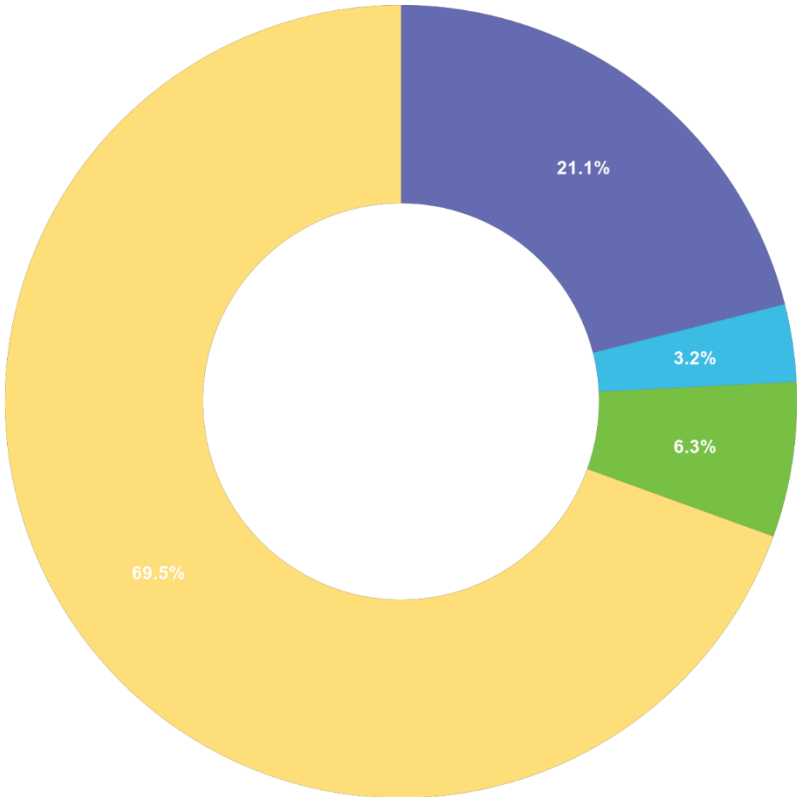
Q7 Have you ever had child care issues (lack of access or affordable, safe child care) when working?

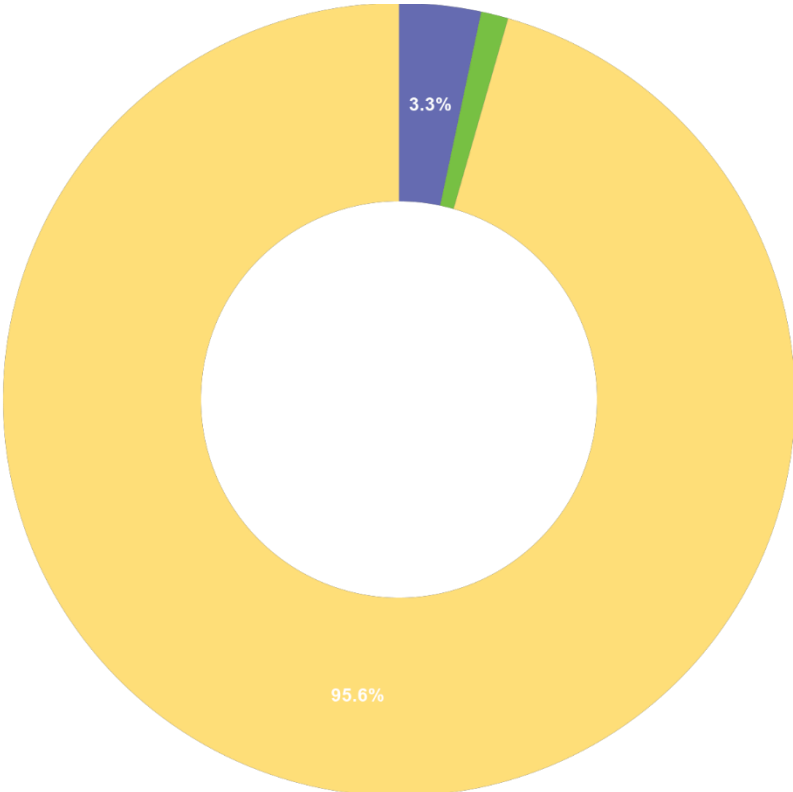
Q8 Have you ever been refused advancement or promotion based on your gender?

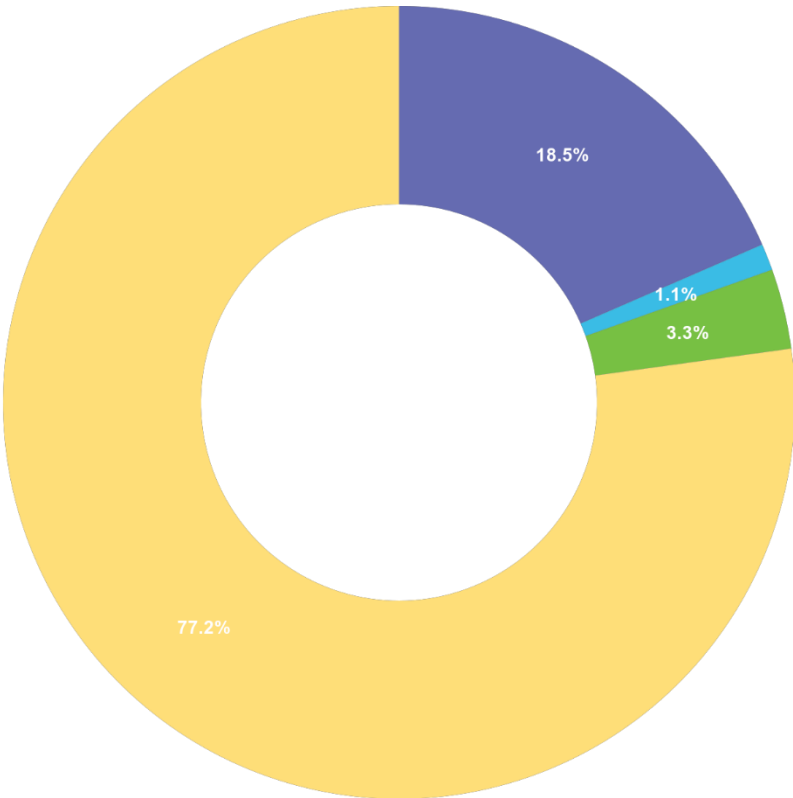
Q9 Have you ever been refused family medical leave, to take care of a spouse, significant other or family member?

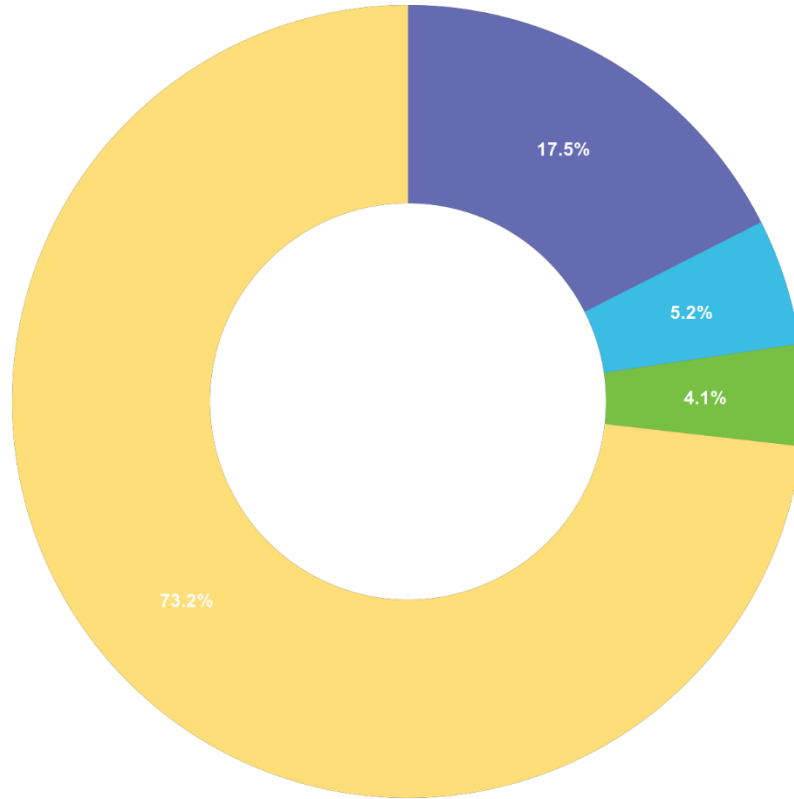
Q10 Have you ever experienced discrimination at work based on your pregnancy status?

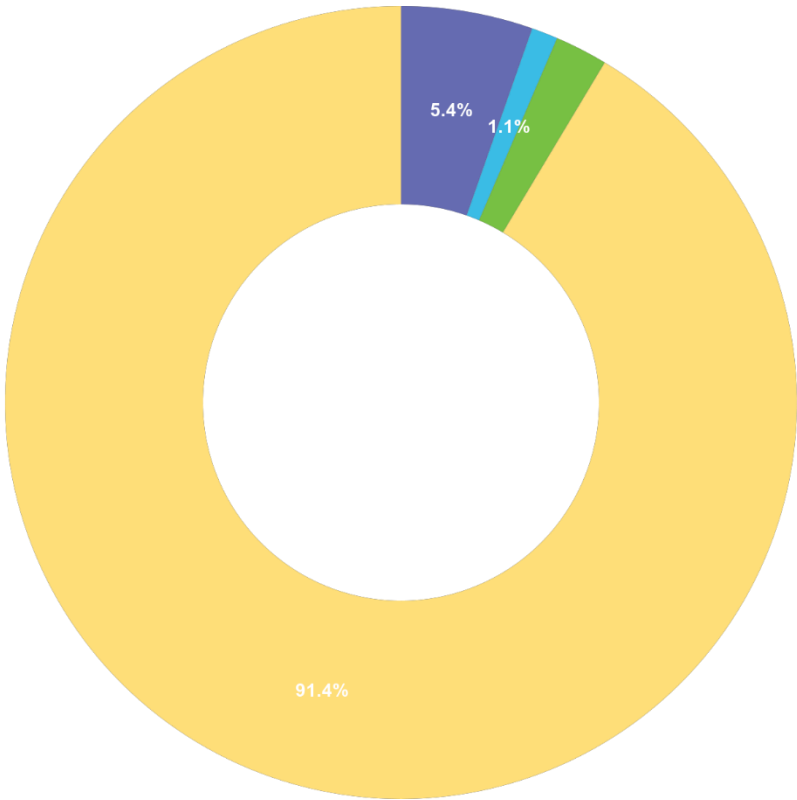

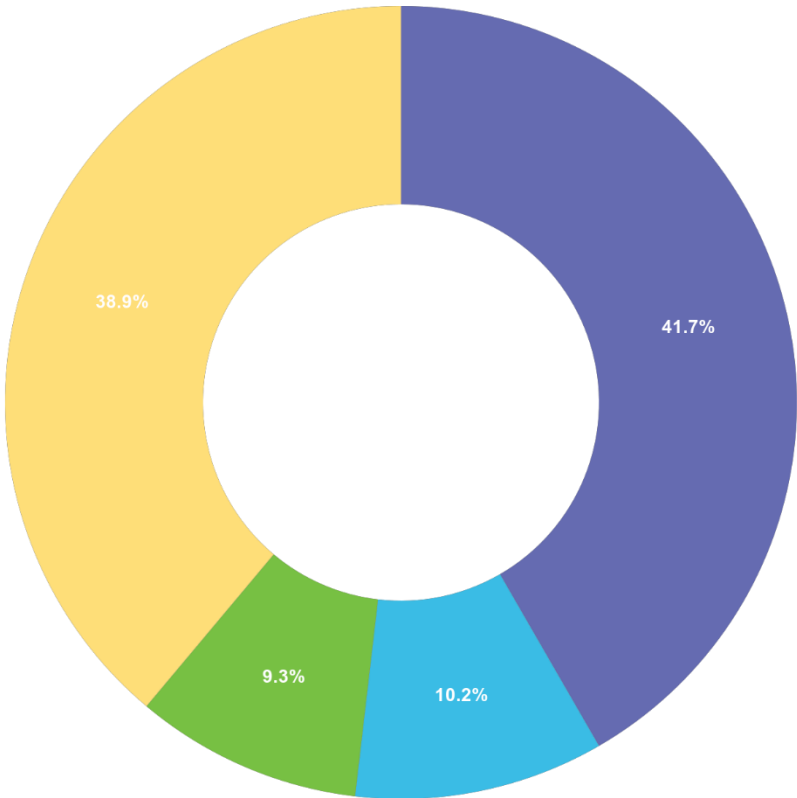

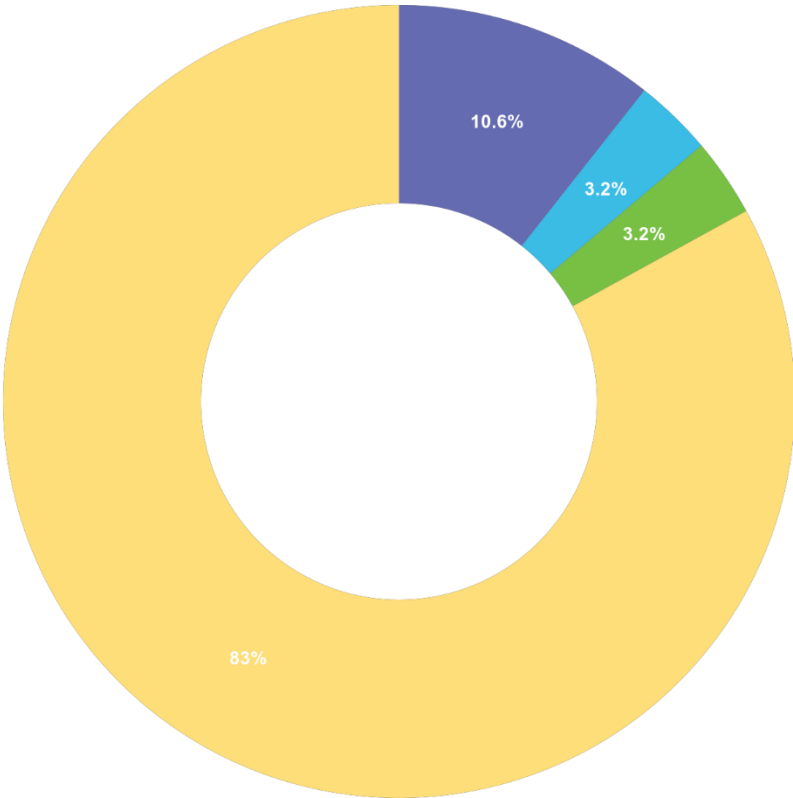
Q13 Have you ever experienced sexual harassment in the workplace?

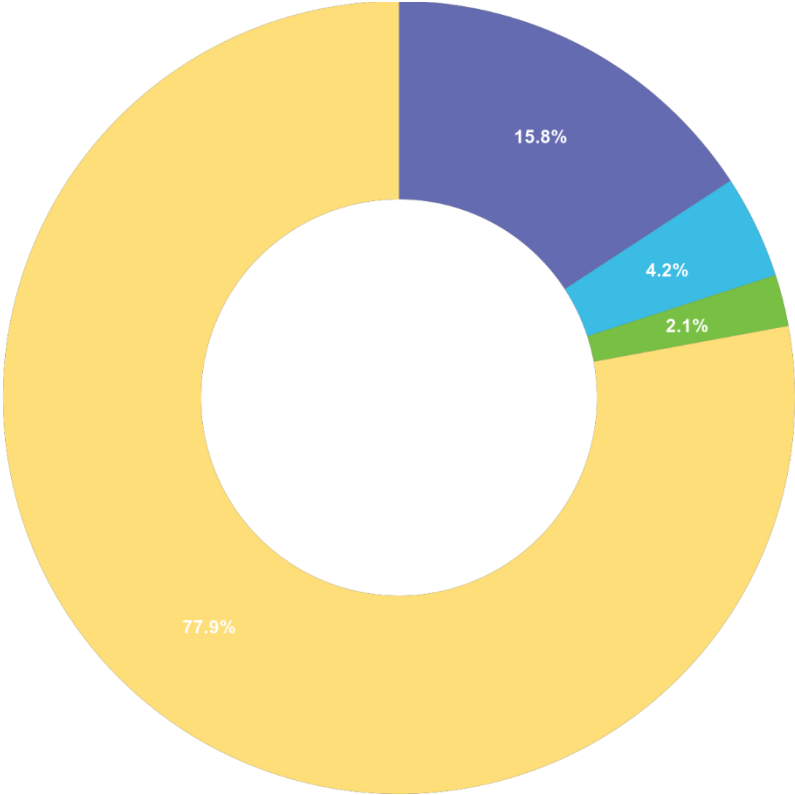
Q14 Have you ever experienced sexual molestation (unwanted sexual/intimate contact) in the workplace?

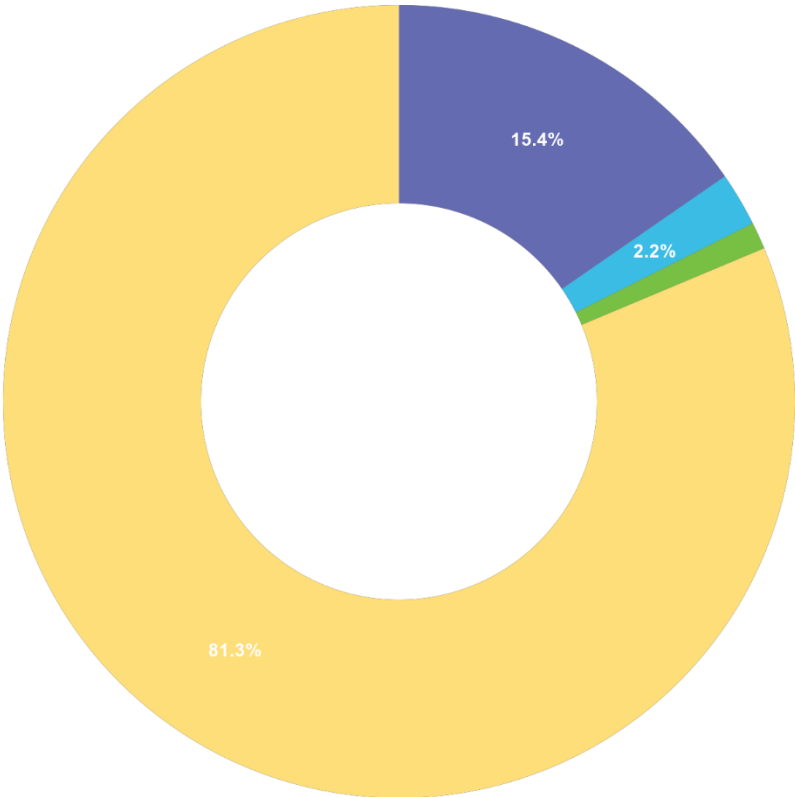
Q15 Have you ever faced gender discrimination in athletic facilities and /or lack of access to team sports?

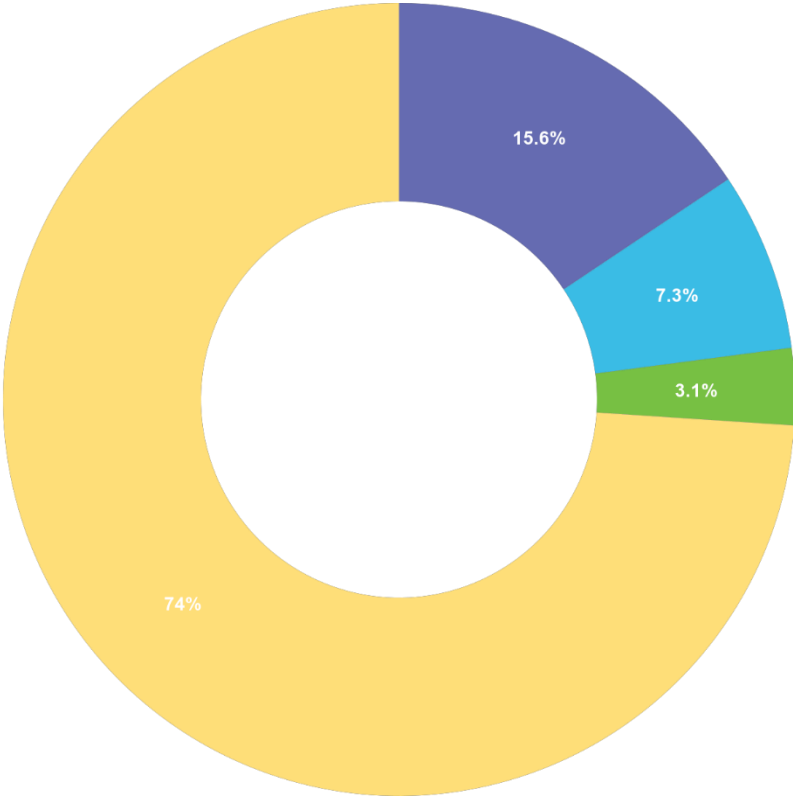
Q16 Have you ever experienced sexual harassment in the classroom?

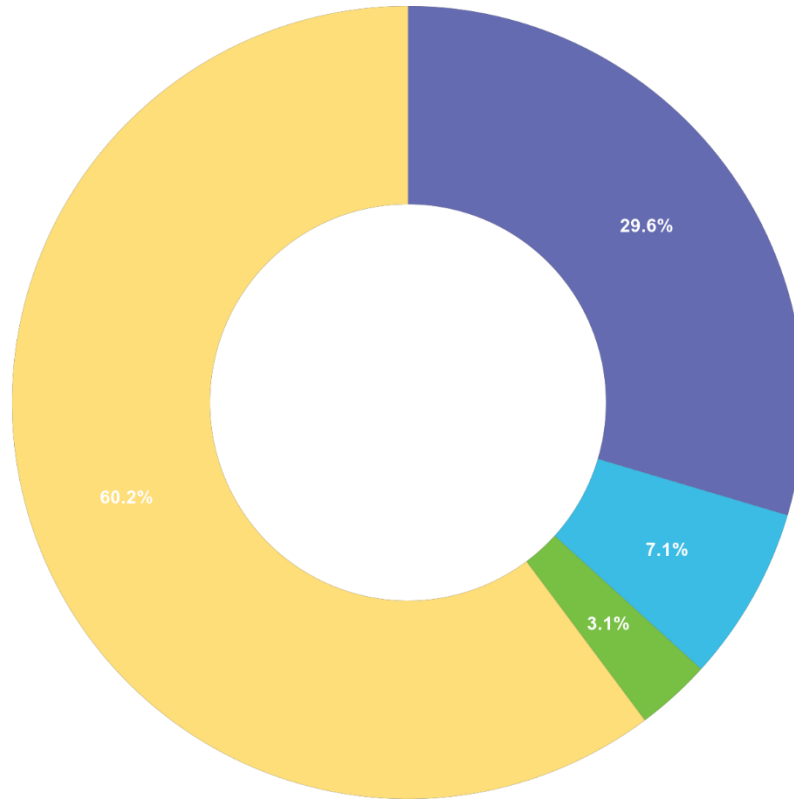
Q17 Have you ever felt that your teachers/professors were not providing equal opportunities to all students?

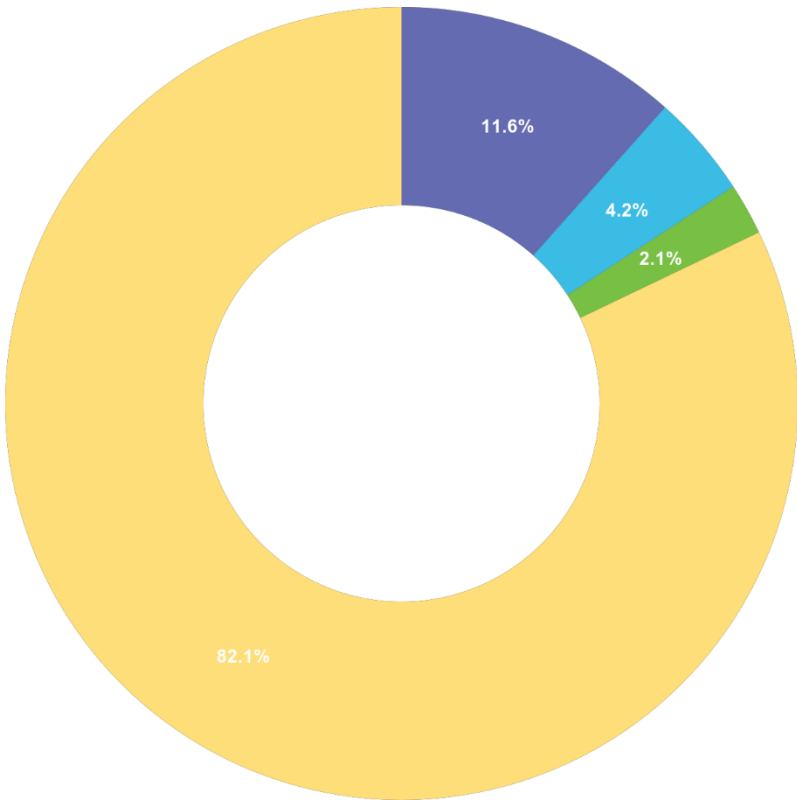
Q18 Have you ever felt that you did not receive adequate reproductive health education?

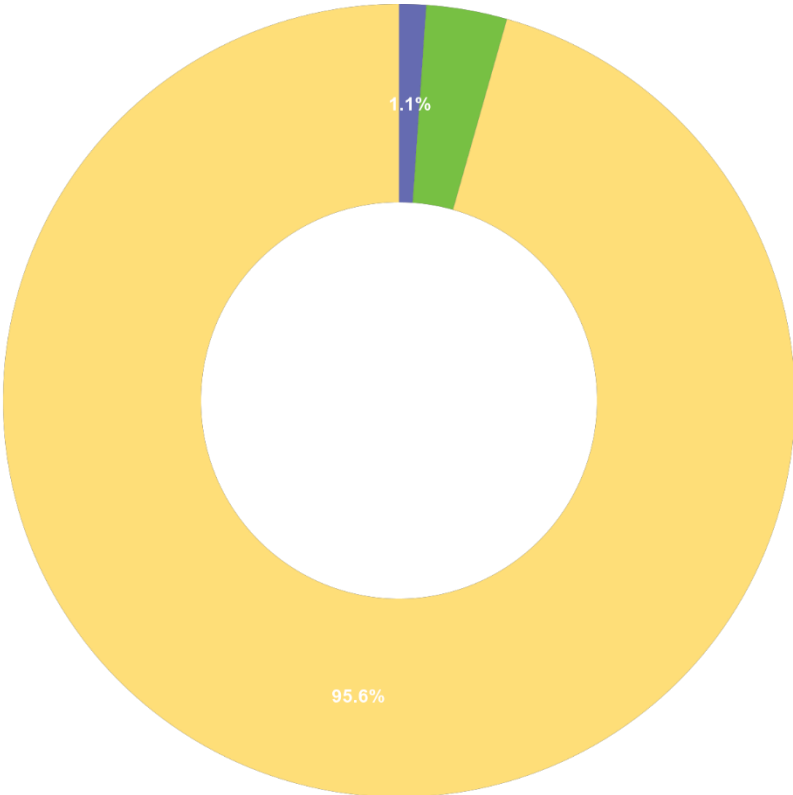
Q19 Have you ever felt limited in your access to equal educational opportunities?

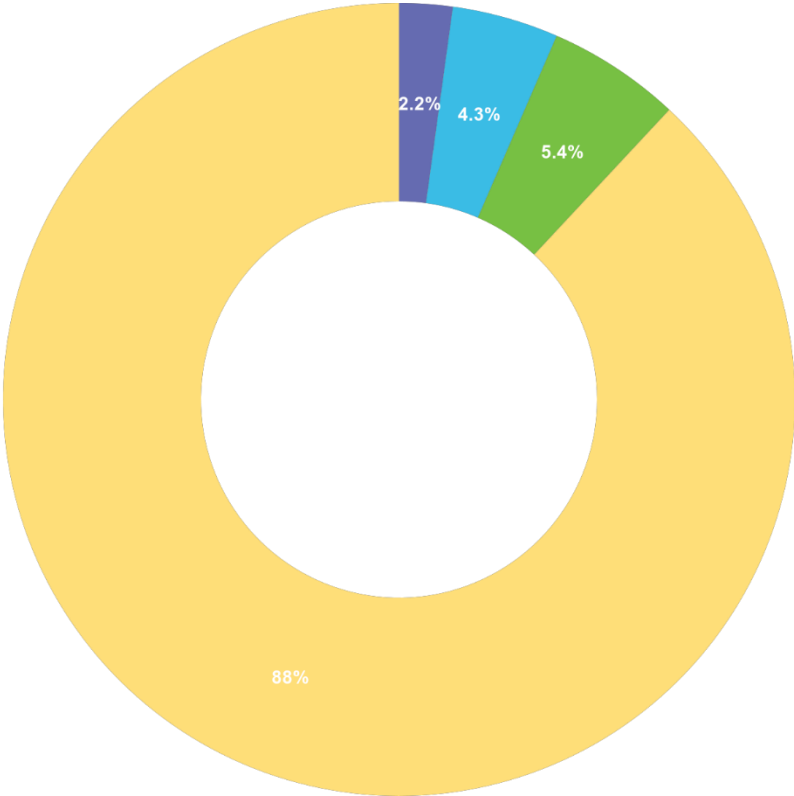
Q20 Have you ever been unable to access adequate legal representation against physical and emotional harassment or abuse?

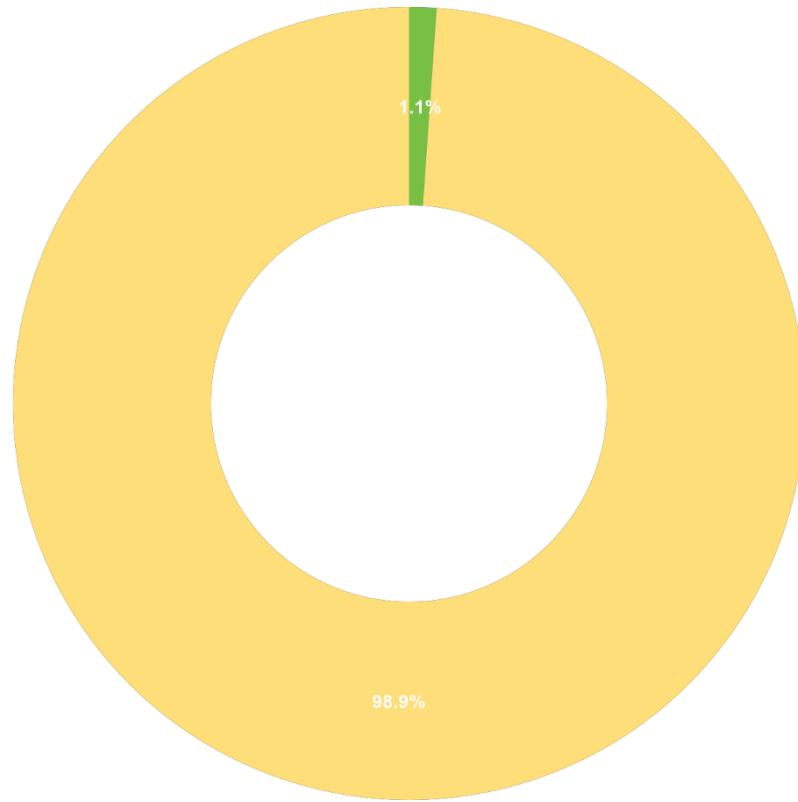
Q21 Have you ever been unable to gain fair divorce settlements?

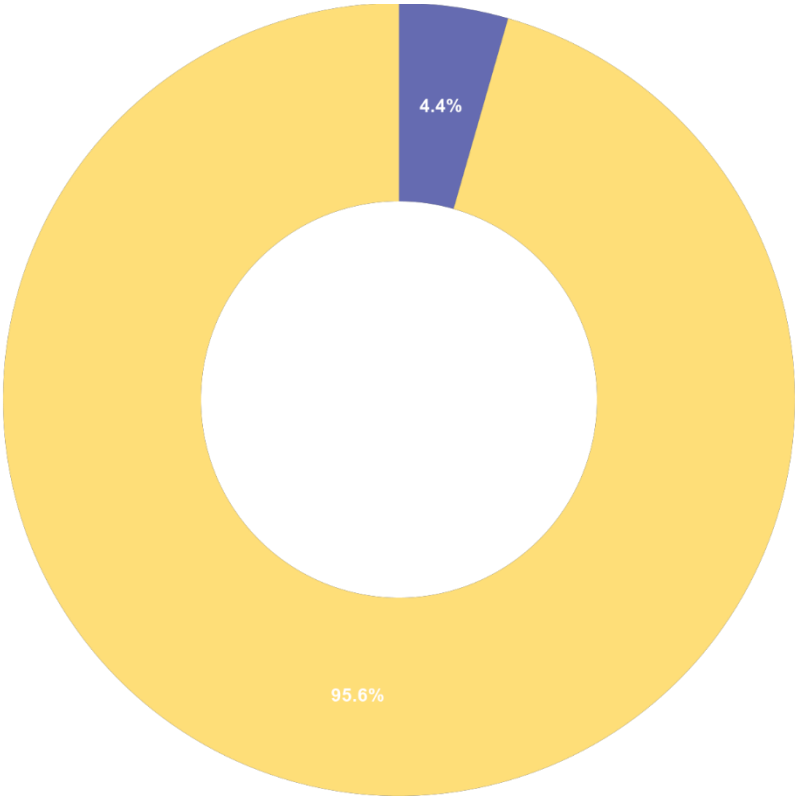

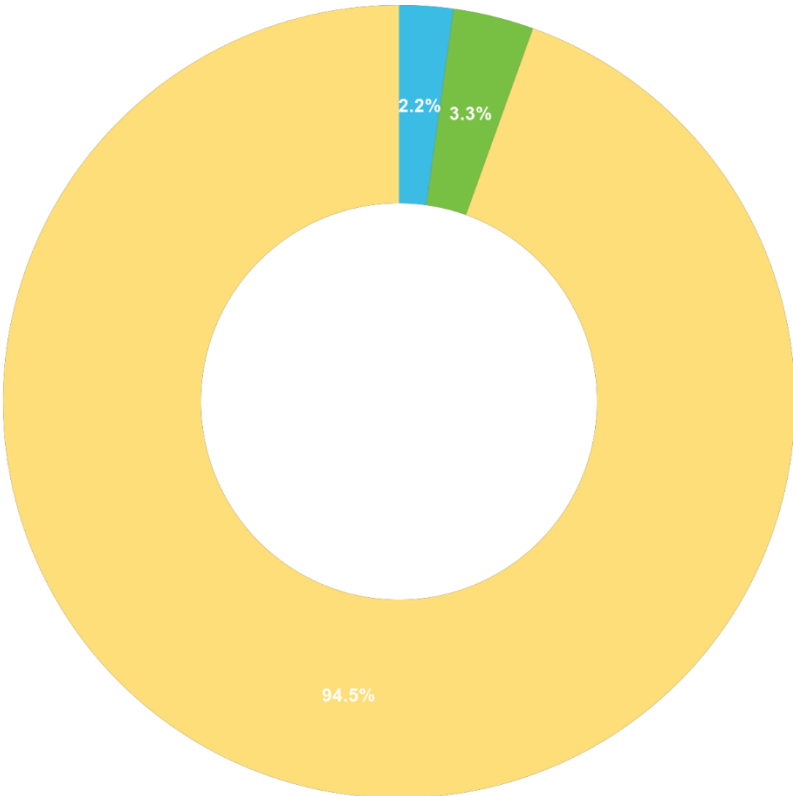
Q23 Have you ever felt you were unable to gain access to effective legal representation due to your gender identity?

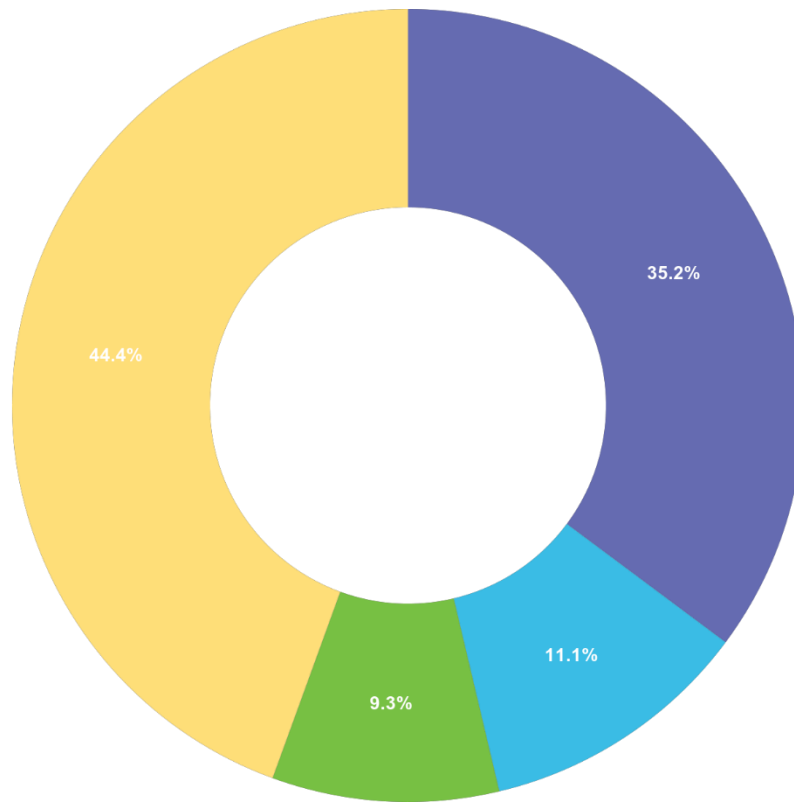
Q24 Have you ever felt you were unable to access adequate advocacy for LGBTQ+ rights?

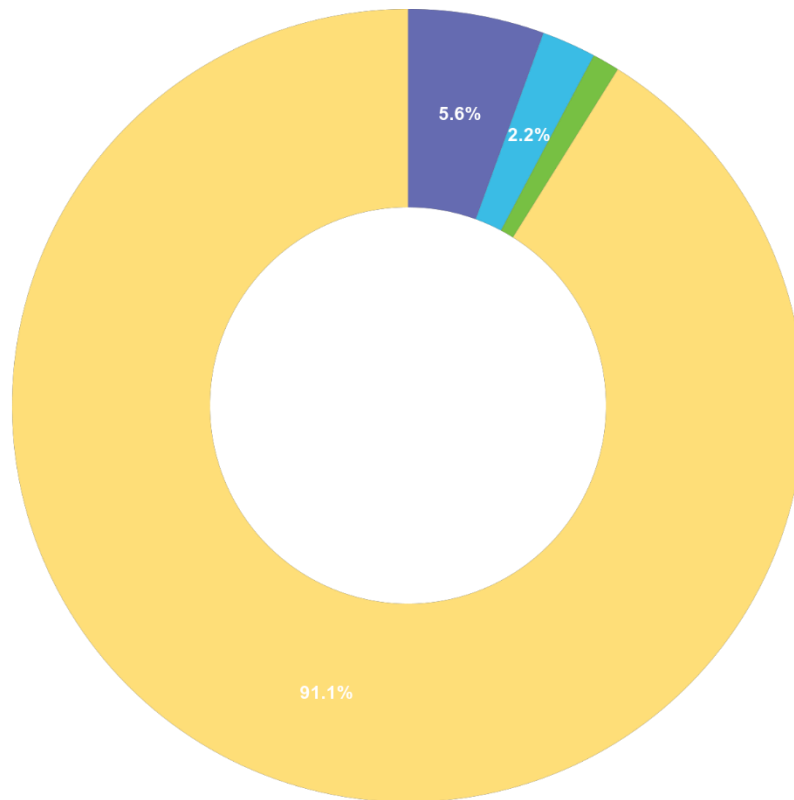
Q35 Have you ever experienced age, gender or sexual discrimination?

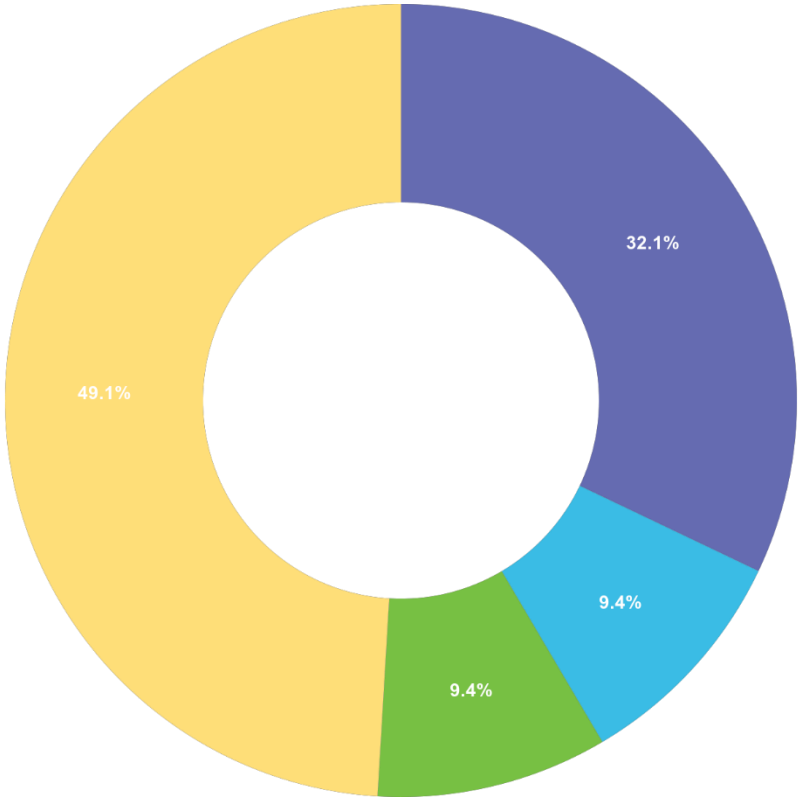
Q26 Have you ever been unable to gain access to effective advocacy due to your gender?

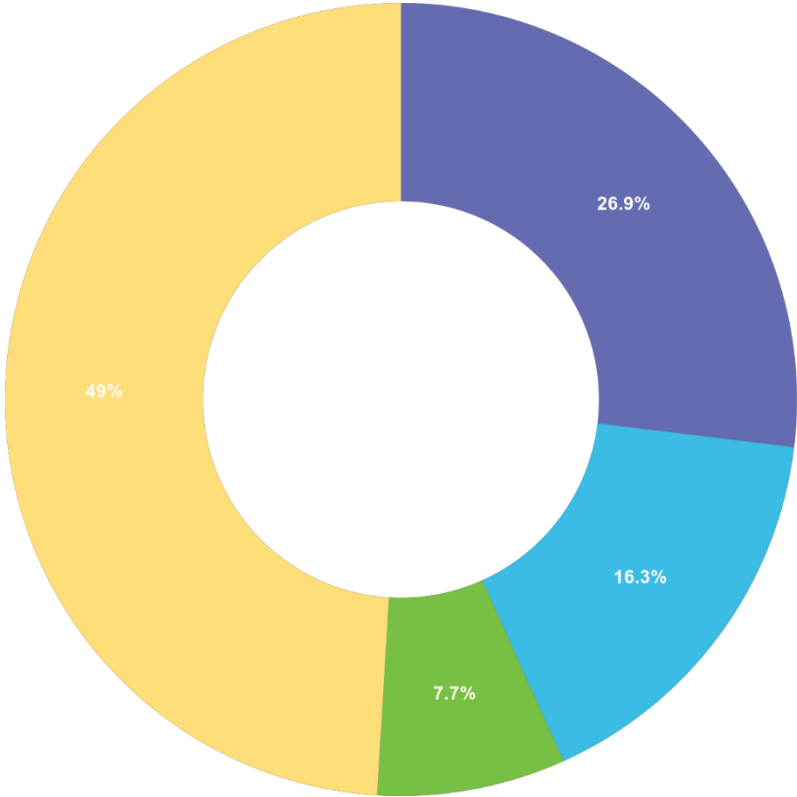
Q27 Have you ever felt that your access to opportunities were limited, based on your gender?

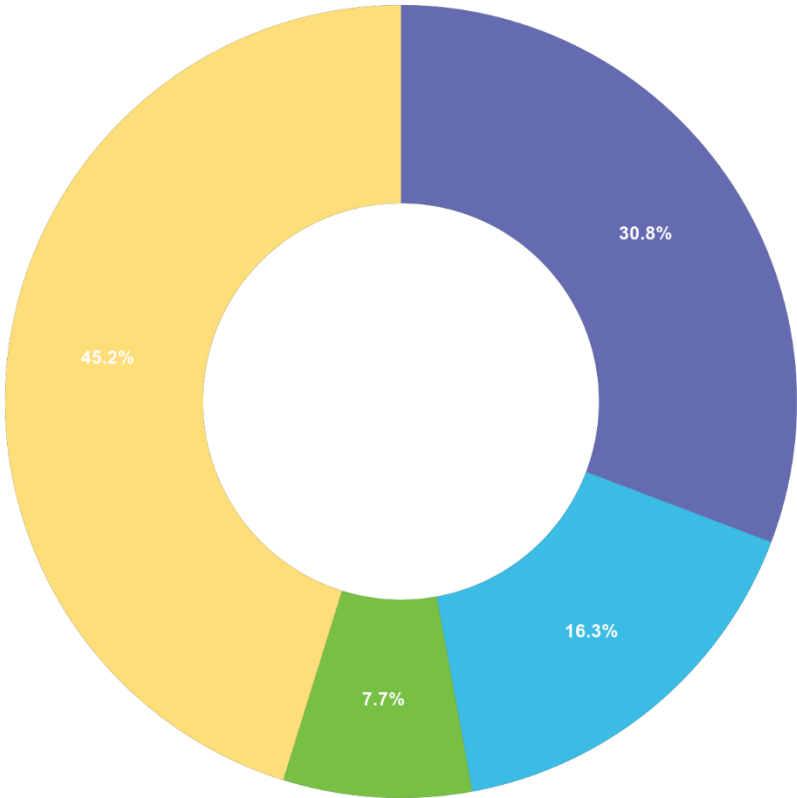
Q28 Have you experienced bullying, either in a school, work or home environment (including online bullying)?

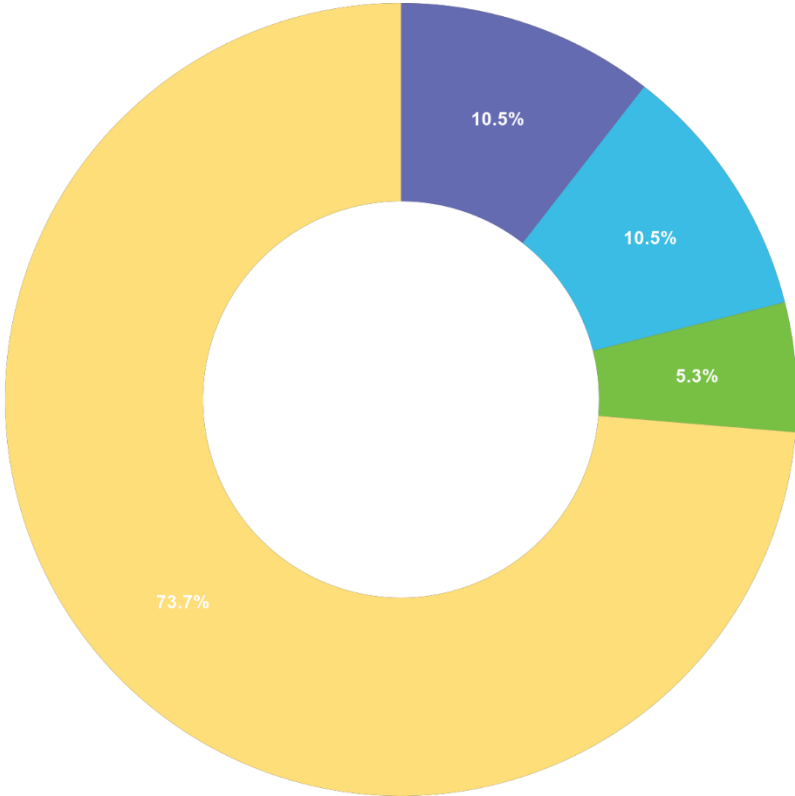
Q29 Have you experienced physical or emotional abuse?

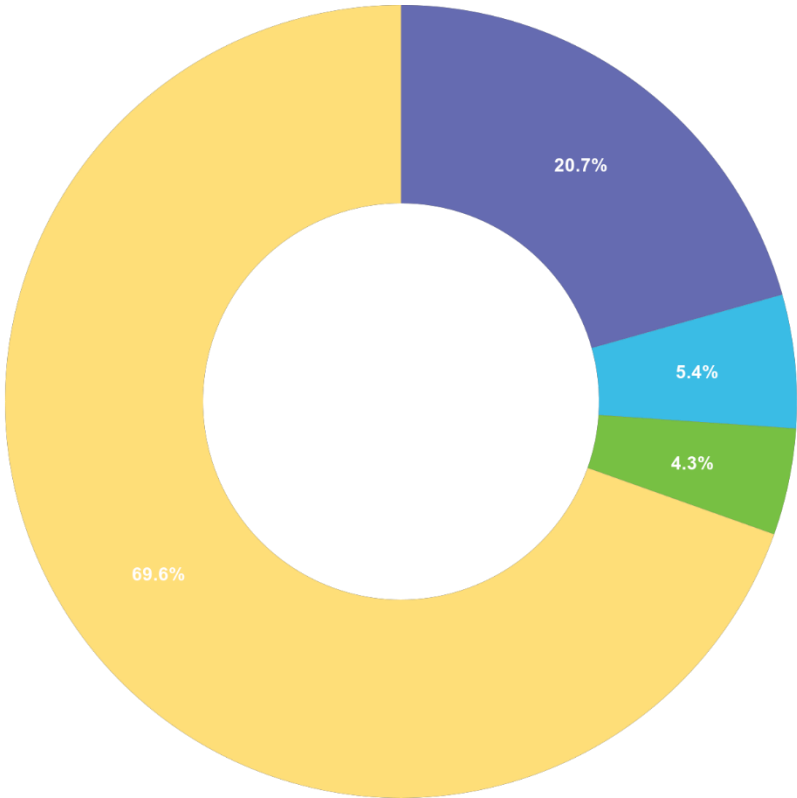
Q30 Have you experienced violence in an intimate relationship?

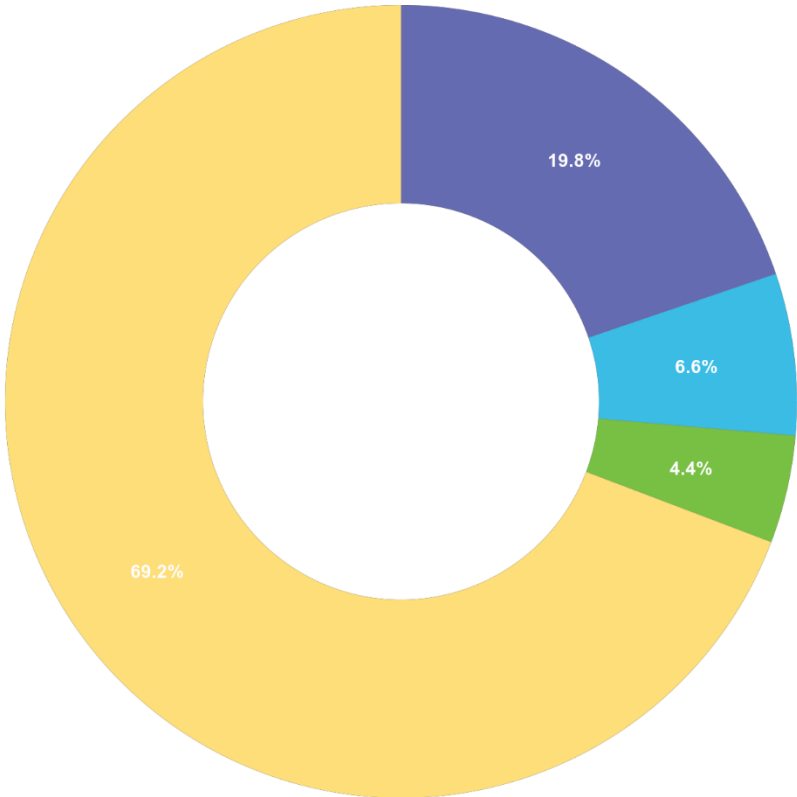
Q31 Have you experienced rape and/or sexual assault?

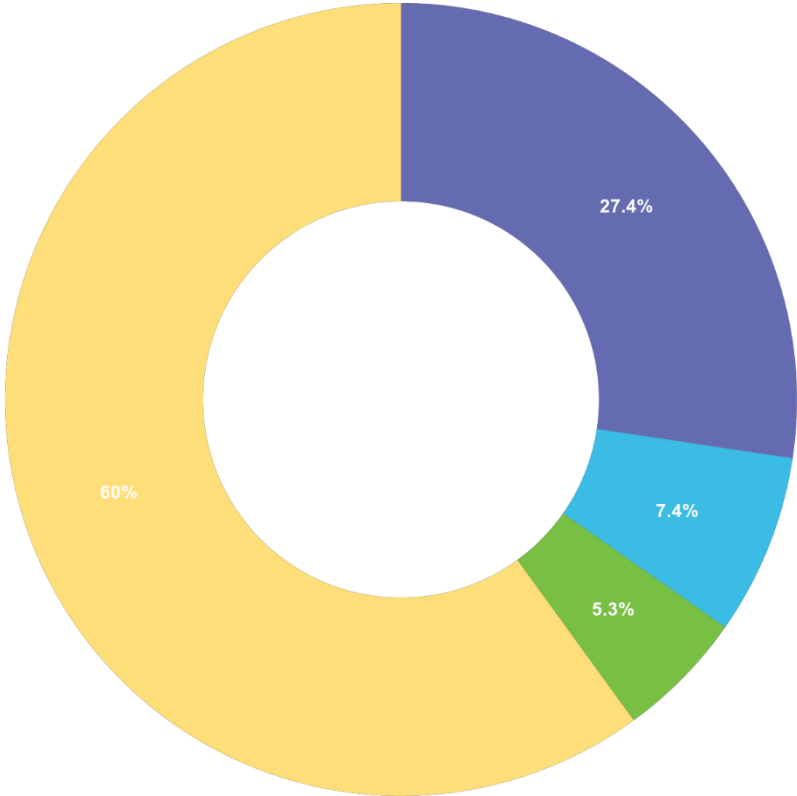
Q32 Have you experienced sexual abuse, either as a child or as an adult?

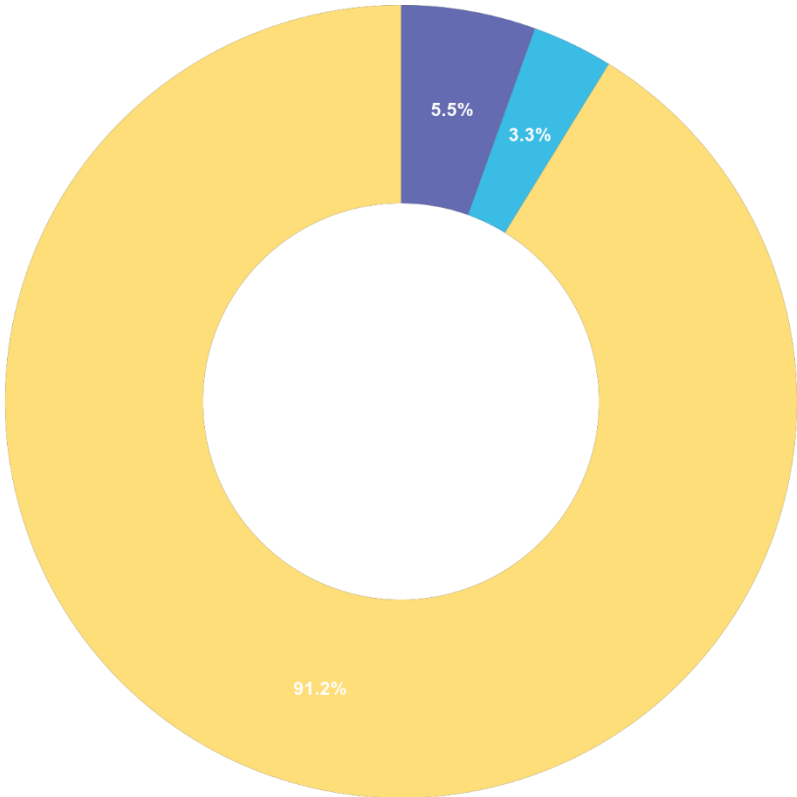
Q33 Have you experienced sexual molestation (unwanted sexual/intimate contact)?

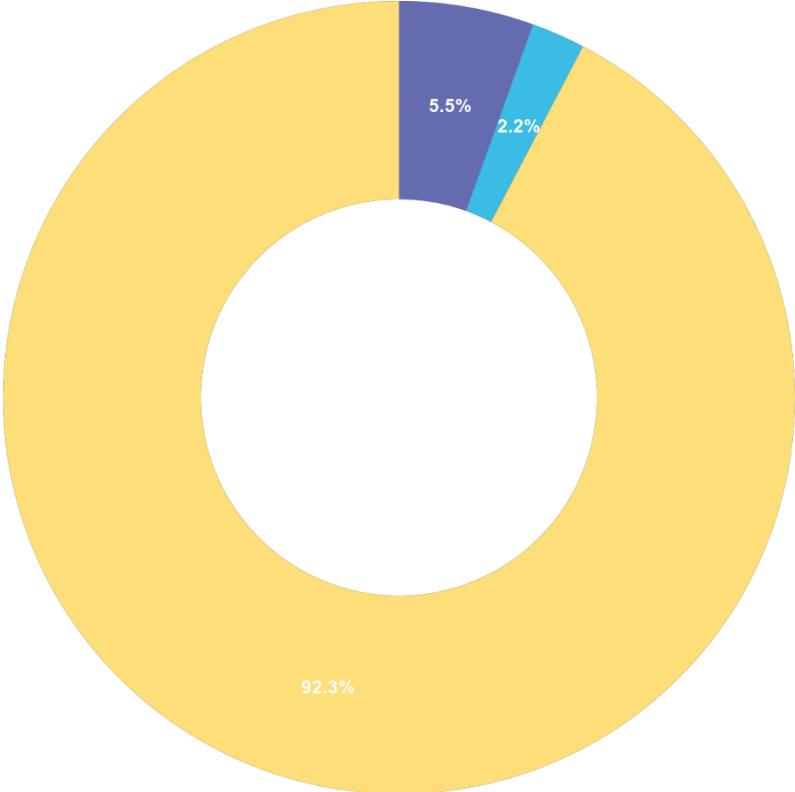
Q34 Have you faced hurdles in receiving adequate reproductive health care?

Q35 Have you encountered obstacles in receiving adequate choices and/or filling prescriptions for birth control?

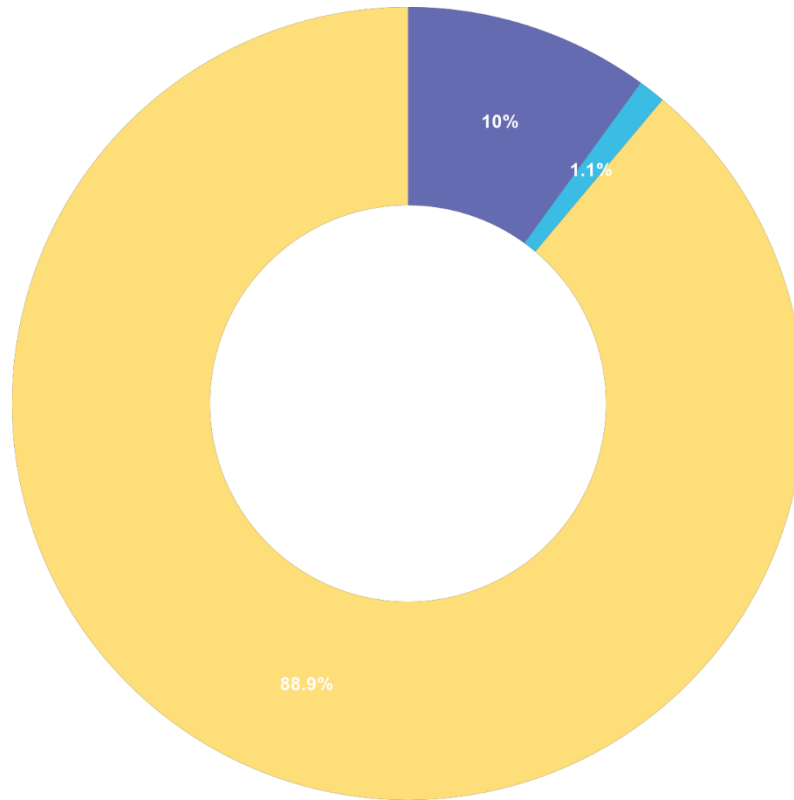

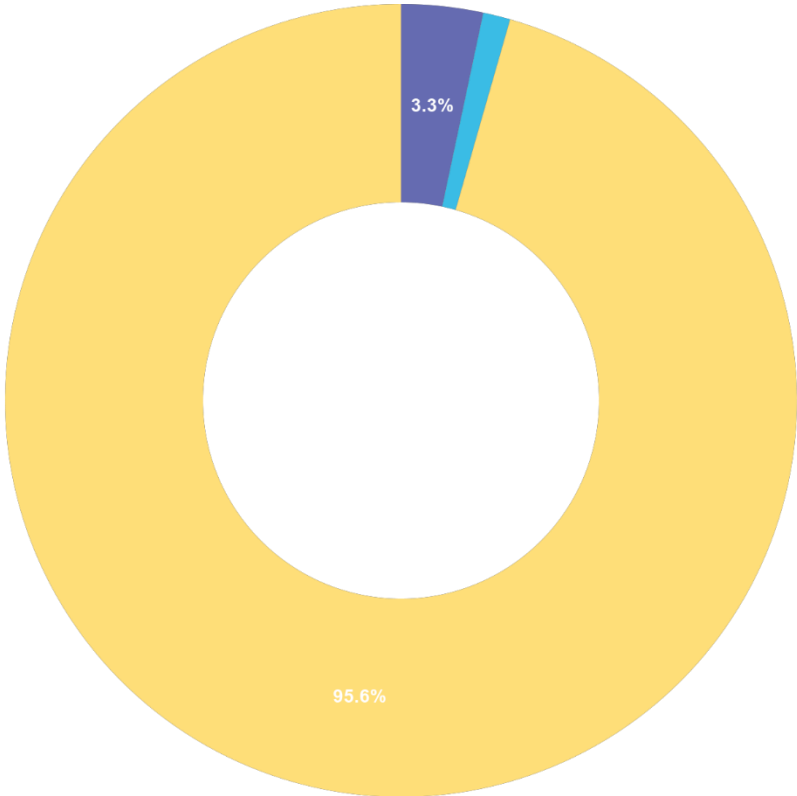

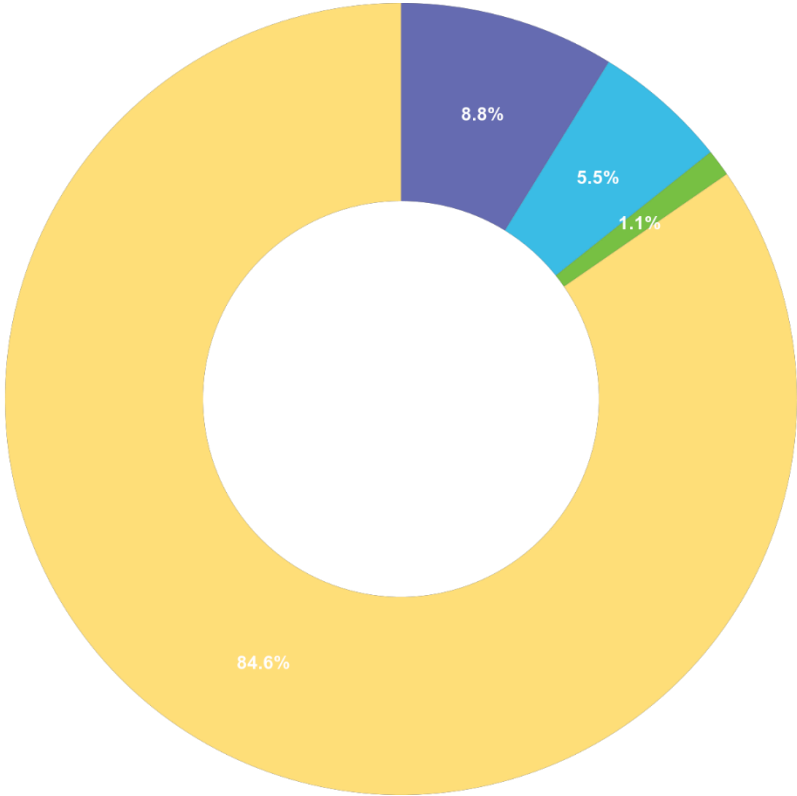
Q37 Have you faced obstacles in receiving adequate maternity care?

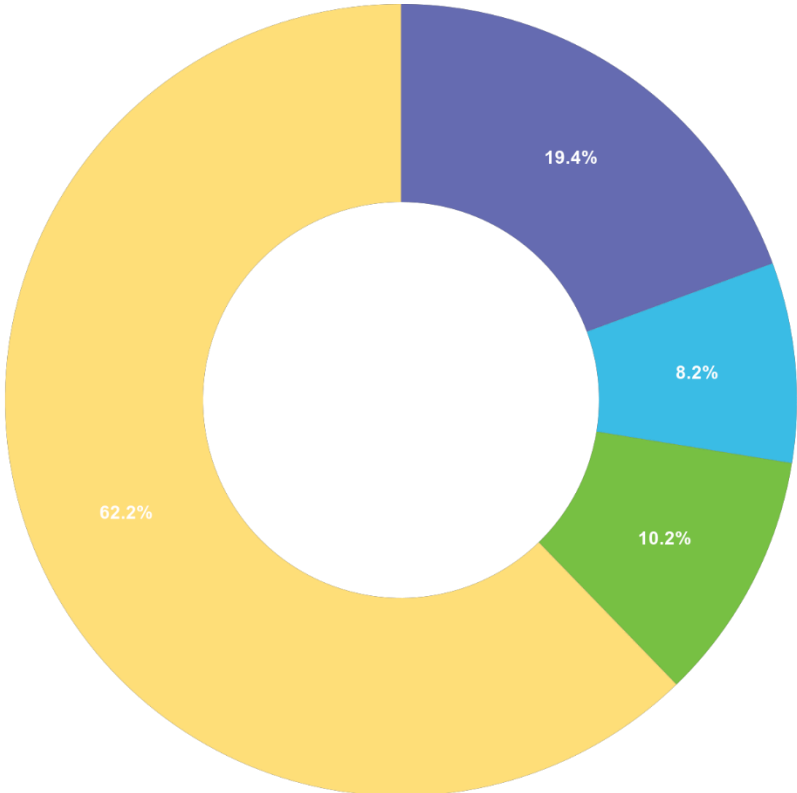
Q39 Have you ever been denied help for eating disorders?

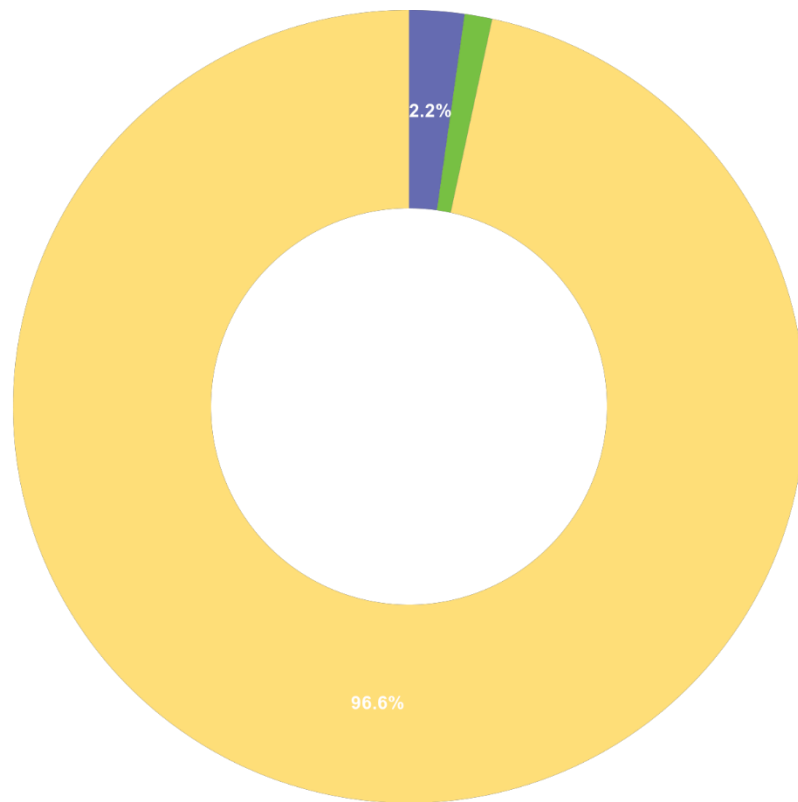
Q40 Have you ever terminated a pregnancy?
